Introduction

Basketball Otago ("BBO") respects the privacy of its members and is committed to protecting your privacy.

Collection of your information

Basketball Otago will only collect personal information that is connected to a function or activity we carry out, and only where the collection of that information is necessary for that function or activity.

You agree that your use of our website or any product or service provided by us, or your membership of Basketball Otago/Basketball New Zealand, indicates acceptance of this Policy and you authorize us to collect, use and share your personal information as outlined in this policy.

We collect information about you (including but not limited to, your name, contact details, age, photograph or other details shown in media, gender, medical/emergency information and payment details) from the information you provide us when you are talking to us, making purchases from us, filling out forms or registering on-line.
